EXECUTIVE LETTER

Dear Friends,

As we reflect on this past year, one thing is clear: the needs across our community have grown and so has the compassion that sustains it.

Every day, our neighbors throughout Puget Sound turn to JFS for support. Rising food prices, soaring rents, and the fraying of the social safety net have left many struggling to meet even their most basic needs: feeding their children, heating their homes, or paying for essential medication.

Yet in this time of challenge, your generosity has been nothing short of extraordinary. You have ensured that our neighbors continue to receive healthy food from the Polack Food Bank, that survivors of domestic violence can find safety and healing, that people with cognitive disabilities are supported to live full and independent lives, and that older adults — including Holocaust survivors — are cared for with dignity and respect.

This year also brought change within JFS. We embarked on an exciting new chapter for JFS as we welcomed Rebekah as Schocken Family CEO. We are both thrilled to steward this organization into its next era of service and impact. We said a heartfelt goodbye to Rabbi Will Berkovitz, whose long-time leadership left a legacy of compassion and strength. Leadership transitions remind us that while times and faces may change, our mission and the values that anchor it remain steadfast.

One of the most difficult moments of the year was navigating the temporary suspension of our federal refugee resettlement program. As a 133-year-old organization founded to resettle refugees and immigrants, this was a painful transition for JFS. Yet it also reignited our determination to continue this critical work in new ways. We have been able to support survivors of trafficking, unaccompanied youth, and other refugees and immigrants with employment services and educational opportunities and resettle

At the heart of our work is a timeless Jewish value: the call to care for one another. Our tradition teaches that every person is created b'tzelem Elohim, in the image of the Divine, and that we have a

sacred responsibility to help those in need, to feed the hungry, to shelter the vulnerable, and to build a community rooted in compassion and justice. These values guide us every day and inspire our commitment to serve all who turn to us, regardless of background or circumstance. It reminds us that our collective strength lies in our shared responsibility to one another; to lift those in need, to repair what is broken, and to ensure that every person is treated with dignity.

As you read our report to the community, we hope you feel the impact of what we have achieved together. Every success story, every meal shared, every act of kindness begins with you. We are deeply honored to do this work in partnership with you.

Together, we will continue to respond to growing needs with open hearts, steady hands, and an unwavering commitment to care.

THE STATE OF JFS

A CRISIS FOR OUR COMMUNITY

“There’s a fabric of the social safety net—you take one piece away, the fabric starts fraying and it becomes a hole, then a bigger hole ... Most of our clients rely on Social Security benefits, Medicaid, food assistance, and government-subsidized housing. Any disruption to those programs will upend lives.”

The past year has been incredibly challenging; government cutbacks threaten essential JFS programs at the same time demand for services skyrocketed. These reductions plus persistent inflation have made it increasingly difficult for our clients to make ends meet.

While specific programs were especially affected in the last fiscal year, these issues impact our whole community as many of our clients have low incomes and rely on food assistance, government-subsidized housing, Medicaid, and other safety net programs. Additional federal funding cuts will take effect in 2026, further impacting our neighbors who are already making hard decisions between purchasing medication and food.

RIISING TO THE CHALLENGE, TOGETHER

Thanks to your generosity, JFS continued to aid our clients and address their growing needs in FY25.

We provided **\$3,659,139 to 527 households** to help avoid eviction, find safety from domestic violence, build stable lives in this country, feed their families, receive in-home medical care, connect with essential services, and join programs designed to reduce social isolation.

FOOD ACCESS

- \$1 billion in federal cuts to USDA food programs means fewer healthy staples for food banks and schools. Food donations for the food bank from key partners have dropped by 75%. The rising cost of groceries means eggs are unaffordable, and meats and canned goods are scarce.
- Supplemental Nutrition Assistance Program (SNAP) benefits have been slashed, which means approximately 170,000 people in Washington are at risk of losing access to food assistance, increasing the number of people and families who need access to food banks like the Polack Food Bank.
- The JFS Polack Food Bank reached record-breaking demand in FY25. We saw a 27% increase in food bank visits in January-June 2025, compared to July-December 2024. And we anticipate another 25%-30% increase in food bank visits in the coming year due to changes in government benefits and rising inflation.

REFUGEE AND IMMIGRANT SERVICES

- Starting in January 2025, the federal government suspended the refugee admissions program, preventing refugees from entering the country. The administration also made asylum to the United States inaccessible and eliminated humanitarian parole programs.
- In response to these shifts, and to significant government funding cuts for these programs, JFS restructured its programs and services to continue supporting refugees and immigrants from around the world to find safety and security.
- JFS remains a beacon of light for refugees and immigrants. 1,588 refugees and immigrants found safe housing and received critical support services from JFS in the last year.
- From January through June, 200 people from Afghanistan with Special Immigrant Visas (meaning

they worked with U.S. forces) arrived at our doorstep seeking help. Thanks to our generous donors, we helped them all build new lives here.

- 43% of Refugee & Immigrant Services employment program participants secured jobs and 91% of those clients still had their jobs three months after they started.
- 82 unaccompanied youth and 30 youth survivors of trafficking received support from JFS; these youth came from Colombia, El Salvador, Guatemala, Haiti, Honduras, India, Mexico, Peru, and Venezuela.





FINANCIAL ASSISTANCE

- 527 households received financial assistance (across the agency) to avoid eviction or regain stability after financial difficulty.
- JFS provided \$3,658,639 in financial assistance (up from \$2,780,826 in FY24, an increase of 31.6%).
- Nearly \$500,000 of the funding helped people stay in their homes and prevent eviction.
- 81% of clients who received financial assistance are Jewish.
- Much of this is possible because of our generous donors, especially the Basic Needs Fund founded by Karen & Gary Schwartz.

OLDER ADULT SERVICES

- 728 older adults and family caregivers received key services such as care management, Elder Connections (pairing volunteers with elders to provide companionship and help with errands and household tasks), Family Caregiver Support, Russian Language Services, and help navigating long-term care and connecting with other resources.
- 198 Holocaust survivors were able to stay in their homes and age with dignity, thanks to in-home medical care, financial assistance, legal and dental services, and socialization opportunities.
- 285 Russian-speaking older adults were able to connect with their peers through social programming designed to reduce the harmful physical and mental effects of isolation.

PROJECT DVORA

- 95 survivors of domestic violence received services from Project DVORA, including advocacy, support groups, financial assistance, and legal advocacy.
- 43 survivors received legal services. We have increased the number of Jewish survivors who receive our legal services — from 6 in FY23 to 31 in FY25.
- 60 survivors received financial assistance (including help with rent, move-in costs, transportation, food, and other necessities) totaling \$143,557.
- 980 people, primarily youth and young adults, learned about preventing domestic violence through JFS outreach programs to synagogues and Jewish schools and summer camps.

SUPPORTIVE LIVING SERVICES (SLS)

- Thanks to our dedicated staff, many of whom have worked with our SLS clients for years and even decades, adults with cognitive disabilities and persistent mental illness who rely on JFS for support have had consistent, compassionate, and dignified help throughout these challenging times. 74 adults with cognitive disabilities or mental health challenges were able to maintain their independence and foster connections through case management (help with applying for and maintaining benefits, health care coordination, and housing and basic needs assistance), non-medical home care, and practical, life-skills training.
- Many SLS clients rely on their small, monthly Supplemental Security Income check to be able to pay their rent, food, medicine, and other necessities. The Social Security Administration



(SSA) has closed offices and fired thousands of employees, putting beneficiaries at risk of dangerous disruptions and delays and impacting JFS staff. JFS case managers can no longer walk into an SSA office to get issues resolved on behalf of clients. They spend many hours on the phone to the SSA, only to get disconnected and start the process over again. In one instance, a case manager worked intensely with one client, who rarely left his house but was required to attend an in-person meeting at an SSA office. The case manager advocated for the meeting to be on the phone because of the client's disability, which SSA agreed to. After 15 phone calls and three phone appointments where the SSA staff member no-showed, the client's benefits were restored.

- Our SLS team offers the highest number of touch points in clients' lives of any of our programs. In FY25, JFS provided 1,814 hours of case management for Supportive Living Services clients.
- 81% of clients who received support from Supportive Living Services are Jewish.

COMMUNITY CONNECTIONS

- 1,046 volunteers lived their values and bagged food, delivered meals, provided companionship, helped elders live with dignity, spread holiday joy, and made a difference for our clients.
- In October 2024, JFS hired Rabbi Ronit Tsadok as the Director of Project Kavod, a JFS initiative that ties the vital work we do to the core Jewish values that inspire and guide our mission. In FY25, Project Kavod hosted 103 participants at community events and 156 participants at staff events.

Thank you for turning your values into action and transforming the lives of our clients. JFS has always been a safety net for those in need. With your extraordinary partnership, over the last year we ensured families were fed, Holocaust Survivors received dignified care, individuals with disabilities were cared for, families were able to stay in their homes, survivors of domestic violence were kept safe, and so much more.

Jessica thought her life was on track. She was doing well, she liked her job, and she had a supportive community. Then, a cascade of unexpected hardships occurred.

Out of the blue, Jessica found out that her life partner of 32 years was living a double life and he disappeared. He left her with an apartment she couldn't afford on her own. Utilities were going up, and so was her rent. Then Jessica's brother died from suicide. She was reeling from grief and struggling to find the energy to look for a new apartment. Six weeks later, she was caught up in unexpected federal layoffs. In a 4 p.m. work meeting, Jessica was told "this is your final day—pack up your things and leave." She lost her healthcare, couldn't afford therapy, and had trouble paying her bills. Trying to get through the paperwork to get unemployment benefits was a nightmare.

That's when Jessica went to the Polack Food Bank.

She lived nearby and had walked by it before but never thought she'd need it.

Jessica told us, "JFS literally saves people's lives. I could not have come through this period without your help. This was the darkest place I've ever been in my life. The food bank is the reason I had enough food to eat. It also saved me emotionally—everyone at the food bank always showed such warmth and compassion. Seeing you all each week was a bright spot that gave me hope for the future and belief in the kindness of humanity. I can't say thank you enough for everything you all do, you are an inspiration."

Fortunately, Jessica's coworkers stayed in touch, and her boss was eventually able to hire her again. She's thrilled to be back and is doing well.

"I didn't see any of this coming. It could happen to anybody. You think everything is fine. It can change overnight," said Jessica.

When Miriam unexpectedly became pregnant at age 38, she realized it might be her only chance for a child. Her boyfriend didn't want the responsibility of a child, so they broke up when she was six months pregnant. He couldn't pay child support and neither his parents nor hers would help. She felt totally alone. Miriam struggled to work and pay for childcare. She cried when she went in to get food stamps because she felt humiliated asking for help. Fortunately, Miriam was accepted into low-income housing in Issaquah. But childcare got so expensive that she had to quit working.

Miriam told us, “I remember the first time I received help from JFS like it was yesterday. My gas tank was empty. I was out of baby food and diapers. I thought ‘I can't do this. I can't provide for my daughter or myself.’ I didn't have anybody. I was so tired all the time. I called JFS and it was such a blessing. My case workers have all treated me as not just a client, but a member of the community. They showed genuine interest in my well-being.”

Over the next 10 years, JFS helped Miriam with financial assistance, food from the food bank, and holiday gifts. Miriam said, “For many years, JFS was the main supporter of our small

family. You were the loving family presence I so desperately needed. Having someone believe in me was so incredibly important.”

JFS enabled Miriam to break the cycle in her family and show up for her daughter, who is now 29 years old. “Without your presence in our lives, my daughter may not have chosen to be a mother. I am thankful every day for my granddaughter. And I'm trying to be the presence and support I did not have. Thank you so much for playing such a meaningful role in our lives. And helping us continue our faith in current difficult circumstances.”

Miriam is still connected with JFS and in the past few years has received grocery gift cards, financial assistance with rent and utilities, and gift cards to buy holiday presents through our Chanukah Tzedakah program.

Miriam wanted to share a message with anyone who is considering supporting JFS: “Anything you donate to JFS, will be a mitzvah and make the difference not only for this generation but for other generations. You give people a sense of hope. You'll never know the good that comes from helping others,” she said.





FRESH FOOD ACCESS THROUGH THE JFS GIVING GARDEN

In FY25, we started a “Giving Garden” in an empty lot that JFS owns, across the street from our Capitol Hill office. Staff and volunteers worked together to build raised beds; plant fruits, vegetables, and herbs; remove weeds; and water the garden throughout the spring and summer. The objective of this garden is to build community and offset some of the decreases we’ve seen in healthy food donations to the Polack Food Bank. The Giving Garden is a joyful, colorful way to showcase the food bank and share stories about fresh food access.

Many people worked together across the agency on the garden. JFS staff dreamed up this project and created a working group with various kinds of expertise. Our Community Connections team coordinated volunteers and staff who were eager to help with weekly shifts. School groups made art and garden signs. Staff in our Kent office grew plant starts, which was a great team-building connection across offices.

The garden sparked great neighborhood conversations and new connections, including with the Giving Garden Network and our neighborhood p-patch Howell Collective.

We were able to share produce with our food bank clients within 24 hours of harvesting, and often on the same day. Clients especially loved the fresh herbs, as we often don’t have those at the food bank!

In late October, we planted cover crop and garlic. The garden is mostly put to bed for the winter except for fall leaves, which will be put into leaf towers for mulch. We’re looking forward to planting produce and herbs again in the spring!

During the growing season, we harvested many fruits, vegetables, and herbs for the food bank:

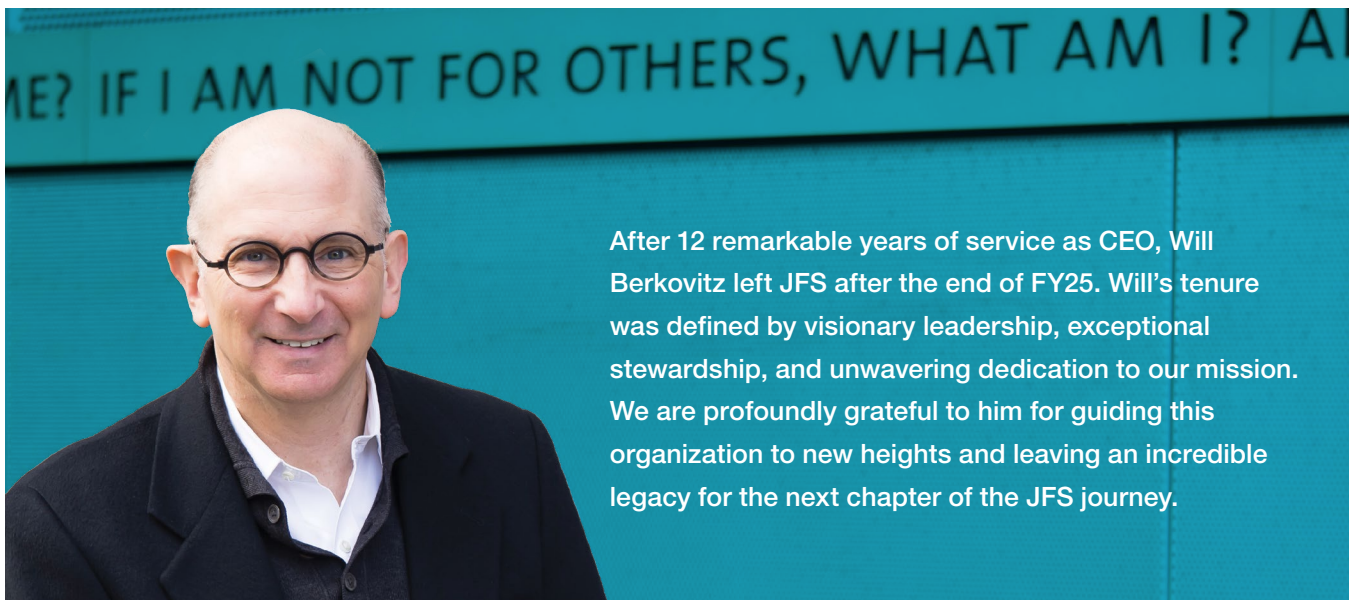

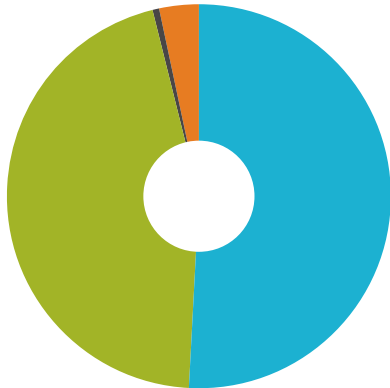
